The curriculum includes core courses in the undergraduate program. In the curriculum, in the 1st semester, there are 20 ECTS and in the 2nd semester, 13 ECTS of core courses, totaling 33 ECTS. This comprises four ECTS elective courses and 29 ECTS mandatory courses.
